In accordance with article 2 of Joint Ministerial Decision Y $\Pi$ EN/ $\Delta$ A $\Pi$ EEK/48653/1597/29.05.2019 (GG 2172/B/07.06.2019), the Residential Accounts of Local Communities with RES Stations and Hybrid Stations which were active on 20.03.2023, date of publication of the "Final Table with the Breakdown of Costs from RES stations in one or more Municipal or Local Communities, for year 2020" are eligible for the return of the Special 1% RES Fee.

As per the provisions of article 4 para. 8 of the above Ministerial Decision, HEDNO S.A. has published the 2nd Provisional List with the Account Numbers of all eligible residential consumers per Community and 1st Grade Regional/Local Authority, which according to the data kept at their computerized system, meet the criteria of article 2 for the following Local Communities with RES stations for which objections have been resolved.

Eligible residential consumers whose active accounts are not included in this list, are eligible to submit to the competent first grade local authority an application for issuing a certificate which will confirm that their active account is located within the limits of the Community whose residential consumers are eligible for the refund/return of the 1% RES Special Fee. Applications by the 1st grade local authorities shall be submitted within one (1) month from the publication of the table on the website of HEDNO SA.

Please note that at the final publication of eligible accounts, and after all confirmation notes by the competent 1st Grade Local Authorities have been received and processed, HEDNO S.A. shall update the list of eligible residential consumers by excluding at this stage all accounts for which the amount calculated is less that one cent (< 0,01 €). In these cases, and according to article 4 para. 8 of the Ministerial Decision, the amounts are not paid and are instead transferred to the next breakdown.
