

PARAGRAPH 13.2 OF THE TENDER PART B "TECHNICAL OFFER"

Remark: In case of doubt due to differences between the English and the Greek version of this document, the Greek version's terms prevail.

The technical offer shall be submitted by the bidder, in Greek or English language, and shall contain the following:

- 13.2.B.1. Quantity and type of the offered materials and services. For this purpose, the bidders shall complete the Technical Offer template in accordance with the relevant Appendix of the Tender.
- 13.2.B.2. Statement of the place and the manufacturing factory of the offered RTUs (Types No 1,2,3 and 4). Detailed information shall be submitted for the manufacturing factory (mailing address, personnel employed, brief description of the plant, description of tests capabilities etc.).
- 13.2.B.3. ISO 9001 certification for the manufacturing factory of the offered RTUs and current sensors shall be submitted, covering the production field of the materials under purchase. It is noticed that the bidder shall guarantee the validity of the submitted ISO 9001 certificates and shall submit communication data with the certification body as well as any other relevant data requested during the stage of technical evaluation, which shall facilitate the verification of ISO 9001 certifications validity. Moreover, a declaration shall be submitted that the manufacturer undertakes the responsibility to take necessary actions in order to ensure the uninterrupted renewal of the ISO 9001 certificates of the manufacturing factories, throughout the duration of any Contract with HEDNO S.A.
- 13.2.B.4. Statement of Compliance of the offered materials in accordance with the technical requirements of the ND-397/16.01.2019 Technical Description and the Supplement 1/26.06.2020.
- 13.2.B.5. Statement of the type of the offered RTU and Current Sensors.
- 13.2.B.6. The following accreditations documents:
 - 1. Sales lists, copies of contracts (it is not necessary to show the unit prices) and/or letters of recommendation (originals or copies), which will demonstrate the factory's capacity in the manufacture of RTUs. These accreditations shall relate to a quantity equal to at least 50% of the number of RTUs provided for in the Declaration. The above accreditations shall relate to the offered or similar type of RTUs.

A similar type of RTU, to be mentioned in the above accreditation documents is an RTU of the same manufacturer, suitable for monitoring and remote control of MV Power Systems, with at least 3 breakers.

Submission of the required documents is not mandatory for manufacturers, who have supplied HEDNO with the same or similar type (according to the above) RTUs. In this case, the bidder shall submit a declaration with the relevant contract numbers.

2. Letters of recommendation (original or copies) referring to the successful installation and operation of the offered or similar type of RTUs at remotely supervised and controlled MV points.



A similar type of RTU, to be mentioned in the above accreditation documents is an RTU of the same manufacturer, suitable for monitoring and remote control of MV Power Systems, with at least 3 breakers.

Submission of the required documents is not mandatory for manufacturers, who have supplied HEDNO with the same or similar type (according to the above) RTUs. In this case, the bidder shall submit a declaration with the relevant contract numbers.

- 13.2.B.7. Statement of compliance with the requirements of the guarantee as described in Chapter 18 of the Technical Description ND-397/16.01.2019 and the Supplement 1/26.06.2020.
- 13.2.B.8. Certificates of successful execution of tests for the offered or similar RTUs, in accordance with §11.1 of the Technical Description ND-397/16.01.2019 and the Supplement 1/26.06.2020. These certificates may fall under any of the columns in Table 6 of §11.1 and should concern either at least the ports of the RTU with No 2, 3, 5, 6, or the RTU as a whole. These certificates shall have been issued by a Test Laboratory recognized by an independent private or public body, without limitation on the range of the available tests (only the laboratory recognition body and certificate ID number shall be stated). Submission of the required documents is not mandatory for manufacturers, who have supplied HEDNO with the same or similar type RTUs. A similar type of RTU, to be mentioned in the above accreditation documents, is an RTU of the same manufacturer, suitable for monitoring and remote control of MV Power Systems, with at least 3 breakers.

In this case, the bidder shall submit a declaration with the relevant contract numbers.

- 13.2.B.9. Completed the Table for the implementation of the REACH Regulation of the EU or a declaration that the offered materials do not fall under the provisions of the REACH Regulation.
- 13.2.B.10. Information Brochures for the RTUs and Current Sensors.
- 13.2.B.11. The below Compliance Sheet filled in.
- 13.2.B.12. Any additional technical information is needed, at the discretion of the bidder.
